### **POLICIES**

1. You must be at least 18 years old to take a Point B Dance class.
2. Classes are paid per class through the Point B Dance Class Portal. No refunds, transfers, credits, or extensions. A dancer may cancel no later than 24 hours in advance through the class portal.
3. Payment is due **BEFORE** taking class. All classes are paid for through the Point B Dance Class Portal. There are no longer pay at the door options.
4. Dancers **must fill out the necessary release forms and pay** to take a class.
5. We will post on social media when a schedule or teacher change is made. We do not notify individual dancers when a teacher becomes unavailable to teach class.
6. Dancers images and videos may be used on the Point B Dance website as well as demonstration of choreography on the Point B Dance You Tube channel. If a dancer does not want to be depicted in either capacity, he or she must notify the instructor before class.
9. No food, drinks, or gum allowed inside the studios. Water is the only exception.
10. Dancers agree to follow the COVID-19 procedures set forth by Point B Dance. Mask policy will be fluid and changing as the COVID-19 evolves. We will state on the website and in each social media post if masks will be required or optional. We ask that anyone that is not feeling well, to stay home. Anyone not following these procedures may be asked to leave.
11. No observers are allowed in the studio. Loitering is prohibited.
12. Camera, video recorders, and camera phones are restricted unless permitted by teacher.
13. Point B Dance is not liable for lost, stolen, or damaged property
